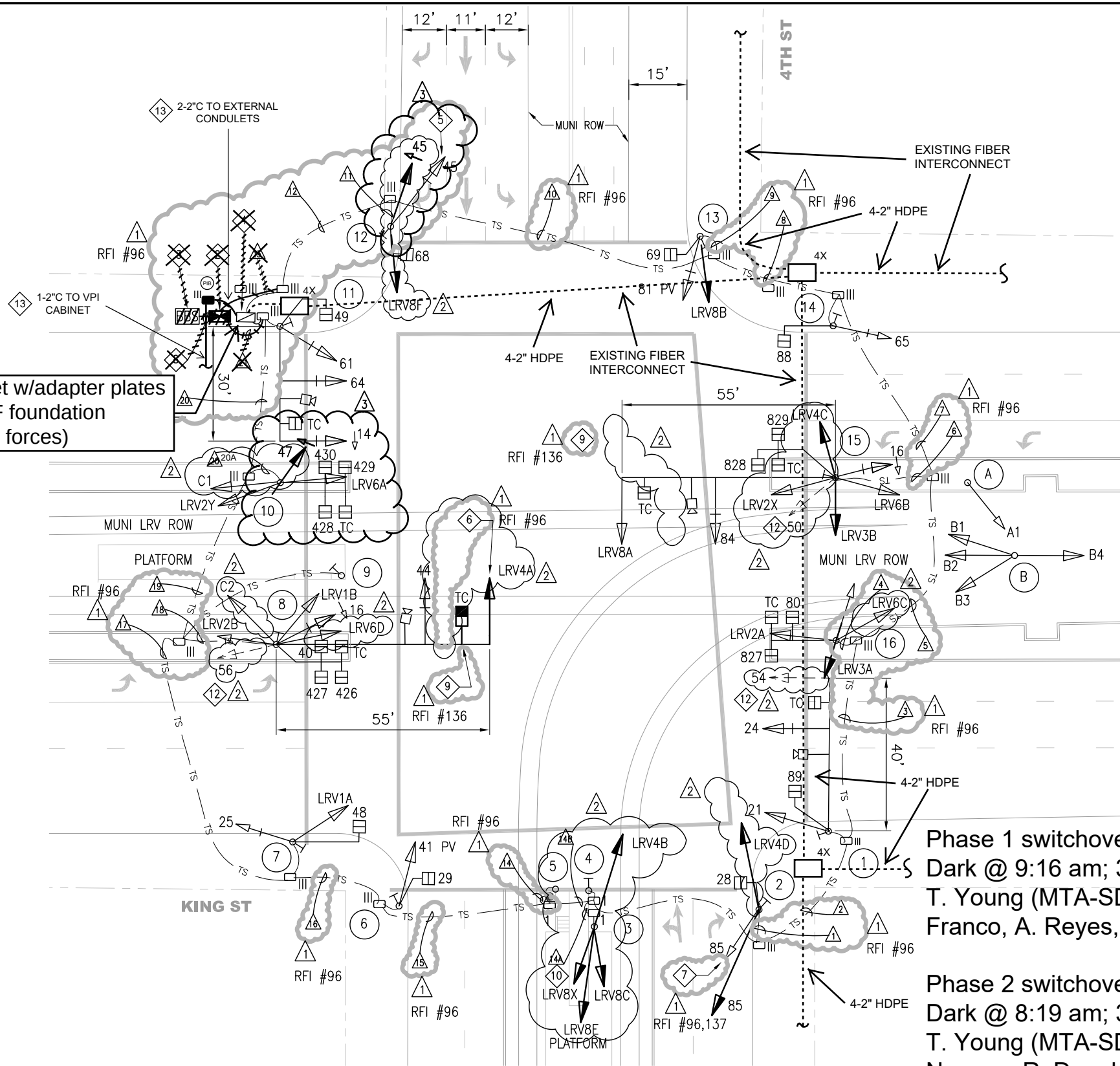


350i-ATC cabinet w/adaptor plates

(installed by City forces)

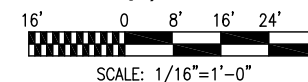
