


INTERCONNECT WIRING DETAIL NOT TO SCALE

- 1 F/I 4-2" HDPE SCHEDULE 80 CONDUIT WITH 3/8" PULL TAPE IN EACH CONDUIT. IN ONE OF THE EMPTY CONDUITS, INSTALL TWO #8 AWG STRANDED COPPER LOCATING WIRES (ONE WITH BLACK INSULATION AND THE OTHER WITH WHITE INSULATION). SEE SECTION 26-05-00 IN CONTRACT SPECIFICATIONS.
- (2) CONTRACTOR SHALL PROTECT SURVEY MONUMENT.
